APPROVAL OF THE MINUTES

A motion was made by Frank Johnson and seconded by Meloyne Wimbley to approve the minutes of the Regular Board Meeting of October 24, 2018. Five ayes, zero nays.

PUBLIC COMMENTS

There were no public comments but Mr. Jordan did mention that Karen Dobner, a friend of a resident at Constitution house, had reached out to the agency to express their concern regarding



no sidewalk access from Constitution house to Constitution Rd. Unfortunately this is not an AHA property, but Mr. Jordan spoke to the manager at Constitution House in order to follow through with the concern and analyze what could be done to address it.

FINANCIAL REPORTS

Mr. Jordan walked the board through every report.

It was also pointed out that write-offs would be done in the next few months to get the bad debt off AHA's books, as it helps the account receivables.

DEPARTMENTAL REPORTS

Public Housing

Maria read off the numbers on her report. REAC inspections returned a score of 71 for AHA which is a passing grade. The score, however, was not high enough to exclude the agency from being inspected the following year. This year the agency scored higher than the previous inspection which reflects the agency's progress. It was noted that in order to exclude the agency from being inspected the following year the agency would need to receive a score of 80 or higher. Maria pointed out that a lot of the deductions stemmed from tenants having furniture in places where they should not be. Unfortunately this is outside of our control, she pointed out.

FOIA training was provided by the agency's law firm to Judy, Tracey, Maria, and Mr. Jordan.

The agency is currently working with City of Aurora to have a sharing agreement worked out in order to address the issue pertaining to the police reports not being shared with the agency.

There was a meet and greet at Maple terrace on November 27. Occupancy rate was at 96%.
